# **Transgendered Officers**

#### **Definitions:**

#### • Transgender – Multifaceted

- People self identify as transgender. There is no "one way" to be transgender.
- Gender identity, internal sense of "who I am" is different from sex assigned at birth.
- Gender identity is considered to be more a spectrum than binary.
- Gender identity, internal sense of "who I am" is different from sex assigned at birth which is usually which is usually based on external genitalia.
- Gender identity is not the same as sexual orientation.
- Transition The process by which a trans or gender nonbinary person makes medical, legal, and/or social changes in order to affirm their gender identity and/or to alleviate dysphoria.
- Assigned sex/gender The sex/gender that was ascribed to a person at birth, which may or may not align with that person's true sex/gender.
- MAAB/FAAB male-assigned at birth/female-assigned at birth
- *Gatekeeping* The practice by which professionals (including social workers) have been empowered by the medical industrial complex, legal and governmental systems, and other members of society to decide the validity of a trans or gender nonbinary person's identity, and to authorize or deny necessary steps in transition.
- Binary gender system/the gender binary The social construct of two specific and exclusive categories of gender: masculine men who are physically male, and feminine women who are physically female

#### **Definitions:**

- Gender A socially constructed system of classification that ascribes qualities of masculinity and femininity to people. Gender characteristics can change over time and are different between cultures.
- Nonbinary, Genderqueer A person whose gender cannot be accurately and/or fully defined by the terms, "male
  " or "female." While a nonbinary or genderqueer person may also identify as male and/or female, many do not. Many see these terms as
  "anti-labels" that tell others more about how to person does not identify, than about how they do. Nonbinary or genderqueer people may or ay not be transgender.
- **Cisgender** A person who is not transgender
- Affirmed Gender A trans person's self-identified gender.
- Gender Expression Th way a that a person uses appearance, mannerisms and other personal traits to communicate their gender. Gender expression can be any combination of traditional masculine, feminine, and androgynous traits.
- "Pass" The experience of a binary-identified trans person being perceived as a cisgender member of their self-identified gender.
- Stealth to conceal one's trans identity. This is often done in response to feeling unsafe in certain situations.
- Gender pronouns/personal pronouns She/her/hers. He/him/his, they/them/theirs, se/hir/hirs, etc. Terms to substitute a person's name, that (in English) usually denote gender. Gender-neutral pronouns should be used for any individual who requests them, or when a given person's pronouns are unknown and there has not been an opportunity to ask.
- **Binding** The process by which a person wears a tight-fitting undergarment other accessory designed to flatten the appearance of the chest beneath a shirt.

#### **Definitions:**

- Gender Fluid A person whose gender identity shifts and changes over time. Gender fluid people may sometimes feel male, and other times feel female, but gender identities experienced by gender fluid people are not limited to the binary.
- Gender nonbinary A person whose gender identity or expression does not conform to societal ideas about what a an/boy or woman/girl should be like.
- Dead Name/Dead–Naming A trans or gender nonbinary person's given name, which the person no longer uses/calling a person by said name.
- Detransition/Detrans cessation or reversal of some degree of transgender medical, legal, or social identification (sometimes temporary)



## Food for thought from TCOPS:

There are transgender law enforcement officers from around the world, in more than 32 countries

There are about 6,400 known transgender LEOs globally

There are about 3,850 known transgender LEOs in the United States

About 500 transgender officers have transitioned genders on-the-job, in the United States between 1975 and 2020

There have been transgender officers in law enforcement as far back as Civil War times, but probably earlier

The first transgender officer to transition onthe-job in modern times, was in about 1975 at the Washington, D.C. Police Department.

## Some things Julie would like you to consider:

Statistically, if an agency has 60+ sworn officers, at least one person in the ranks is transgender

At one agency of 1400+ officers, there were at least 12 transgender officers

At one agency of 1400+ officers, there were *at least 27 family members* of the department with a transgender mother, father, step-parent, grandparent, child, sibling, or other familial relation

### Statistics gathered:

- Statistics gathered through personal contacts with TCOPS between November 1998 & August 2022
- "Transgender" includes those who self-identify as: transsexual, transgender, gender-questioning, gender-queer, gender non-binary, gender non-conforming, or genderfluid
- Contacts were vetted law enforcement officers or law enforcement support personnel
- Contacts are active, retired, or former LEOs or LESPs
