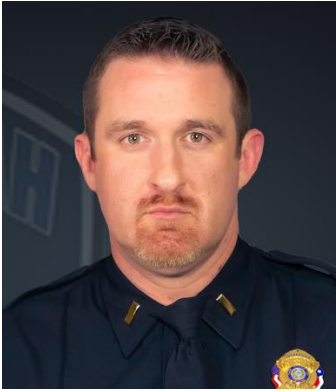


### Detective Sergeant R. Joel Gordon – Shenandoah Police Department

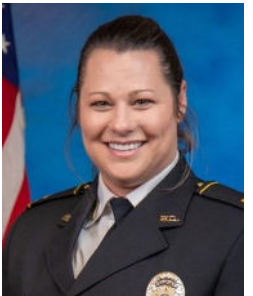

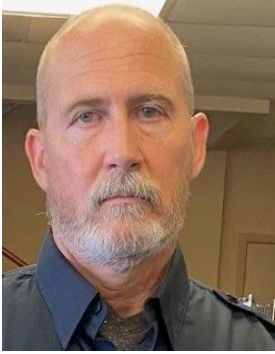


#### **Captain Dennis Paine, Jr. - Rockport Police Department**
